The Defense Occupational and Environmental Health Readiness System-Industrial Hygiene (DOEHRS-IH)



Overview

DOEHRS-IH maintains longitudinal exposure records for military members and civilian employees throughout the Department of Defense (DoD). DOEHRS-IH is the official system of record for the assessment and management of workplace risks/hazards.

Training

To ensure the integrity of the data, the Defense Centers for Public Health – Aberdeen (DCPH-A) provides DOEHRS-IH initial training to individuals who collect and record IH data. The course is based on the DoD training material for the Defense Occupational Health Readiness – Industrial Hygiene Module. The system requires specific training with formal and informal education programs to align with IH core competencies and includes two phases:

Phase 1: This online self-paced phase provides an overview of DOEHRS-IH, including the user interface, data entry, and reporting.

Phase 2: This instructor-led virtual classroom phase provides hands-on experience with DOEHRS-IH, including data collection, sampling, and analysis.

The DOEHRS-IH initial and sustainment trainings are available to approved individuals who collect and record industrial hygiene data.

The Ergonomics and Industrial Hygiene Management (EIHM) Division provides DOEHRS-IH global administration. EIHM Division also provides technical expertise in the development and sustainment of ergonomics and industrial hygiene programs to prevent work-related injuries and illnesses.

The EIHM Division enhances readiness across DoD workplaces and operational settings through the anticipation, recognition, evaluation, and control of hazards.

The division offers a list of services such as:

- Compiling and analyzing industrial hygiene metrics and assistance with metric improvement strategies.
- Staff Assistance Visits and Site Assistance Visits.
- One-on-one mentoring.

- Consults for health risks and hazard management.
- National Defense Strategy alignment to promote and establish Joint Force effort to modernize and strengthen our military to reduce variance in DOEHRS-IH data entry.
- Data mining and analysis in support of:
 - Medical treatment.
 - Occupational and environmental illness evaluations.
 - Disability determinations.
 - Congressional inquiries.
 - Claims adjudication.
 - National Defense Authorization Act (NDAA).
 - Individual Longitudinal Exposure Record.
 - Promise to Address Comprehensive Toxics (PACT) Act.
