Status of an Independent Red Hill Registry:

We are in the early stages of setting up a separate *Independent* Red Hill Registry to be operated by a third party.

The purpose of this registry is to—

- Track your health over time,
- To investigate any health effects, and
- To provide information and support to those who may have potentially been exposed during the Red Hill fuel release.

A separate registry allows for all individuals potentially exposed to be included: affected local populations as well as those associated with the DOD. When the registry is ready, you will receive information on the advantages of enrolling and how to enroll. Sign up is voluntary. Since this registry will continue for years and decades, we want to ensure it functions optimally, so we appreciate your patience as we work through the details.

Public Webpage Coming Soon:

We know you and your family want to stay informed on health-related information, so stay tuned for a Defense Health Agency Red Hill Public Health webpage. The focus will be on health information and upcoming events. Red Hill Defense Occupational and Environmental Health Readiness System (DOEHRS) Incident Report:

The Red Hill DOEHRS Incident Report has also been referred to as the DoD Red Hill Incident Report Registry.

What is the Red Hill DOEHRS Incident Report?

This report is a list of names of DoD workers and residents of military family housing areas served by the Joint Base Pearl Harbor-Hickam water system.

What is the difference between the Red Hill DOEHRS Incident Report and the independent Red Hill registry mentioned in the last e-Update?

The Red Hill DOEHRS Incident Report serves as a formal record of potential exposure to the November 2021 fuel release at Joint Base Pearl Harbor-Hickam. You can think of this report as a limited "Registry 1.0" without the functionality to send, receive, and store individual health questionnaires. In addition, the Red Hill DOEHRS Incident Report does not include potentially exposed people who are not DoD-affiliated. The independent Red Hill registry will have the ability to send, receive, and store individual health questionnaires and can include individuals who are not DoD-affiliated. The Defense Health Agency (DHA) is committed to supporting both the Red Hill DOEHRS Incident Report and an independent Red Hill registry.

How do I know if I am listed in the Red Hill DOEHRS Incident Report?

In early 2022, sponsors of families in military family housing areas served by the Joint Base Pearl Harbor-Hickam water system received a letter notifying them that they were listed in the Red Hill DOEHRS Incident Report. If you would like to confirm that you and your family are listed, please send an email to dha.redhill@health.mil and include your full name and phone number. Do not include protected information such as dates of birth or ID numbers.

What are the benefits of an Independent Registry?

As we discussed at our January webinar, an Independent Red Hill Registry for those exposed to the November 2021 Red Hill fuel release is the best means to study the long-term health impacts from the fuel release, and we strongly encourage you to sign up when the registry is ready for enrollment. The UH has full independence to plan and execute the registry to support those exposed to the fuel release, as well as the greater public. DoD will not approve the registry design, questionnaires, or findings and conclusions, and DoD will not receive individuals' data.

When can I enroll?

The Independent Red Hill Registry will take time to develop to ensure it tracks long-term health impacts effectively. No pre-enrollment is available. The UH will determine when open enrollment begins, and we'll notify you through multiple ways, including DHA e-Updates. Remember, enrollment in the Independent Red Hill Registry will be voluntary. For now, individuals who are interested in receiving updates on the registry's development and community engagement efforts are encouraged to sign up at this UH website.

What is the status of the original DoD registry?

Defense Health Agency Public Health will continue to operate the Red Hill Defense Occupational and Environmental Health Readiness System (DOEHRS) Registry for DoD-affiliated individuals only. The Red Hill DOEHRS Registry, which currently includes 55,768 individuals, is a list of names of DoD workers and residents of military family housing served by the Joint Base Pearl Harbor-Hickam water system. Why a National Academies report?

Many people exposed to the Red Hill fuel release, and their doctors, have questions about the long-term health risks of fuel exposure and what should be done to monitor their health. The National Academies are known for their unbiased, scientific advice on complex issues that inform public policy decisions.

How can I get involved?

The Red Hill study will include community engagement, and representatives will be given the opportunity to share their experiences with the Committee. Previous studies led by the National Academies, such as the 2022 Guidance on PFAS Exposure, Testing, and Clinical Follow-Up, have involved similar engagement activities. If you are interested in participating, please respond to the call for community members. The National Academies will reach out to hear about your concerns and experiences.

When will this report be available?

The final report should be published in about two years. While this may seem like a long wait, gathering information, analyzing data, and writing a report with expert review takes time. The final product will be a valuable resource for affected individuals, healthcare providers, and policymakers.

As I mentioned at the July 16, 2024 webinar, I will be retiring soon from the Air Force. Defense Health Agency (DHA) Public Health will continue to actively lead the Department of Defense's public health response to the Red Hill fuel release, partnering with the National Center for Disaster Medicine and Public Health of the Uniformed Services University of the Health Sciences.

We are at a turning point in the overall Red Hill public health response. We must bring in outside experts to address important remaining questions. The University of Hawai'i (UH) is planning the Red Hill Independent Health Registry, which will enable long-term study of the health effects of the Red Hill fuel release. The National Academies of Sciences, Engineering, and Medicine are beginning the process toward eventual publication of a consensus study report on Red Hill health. Both UH and the National Academies will be engaging directly with those exposed to the fuel release.

For those impacted by the fuel release, Defense Health Agency Public Health will continue striving to partner with you. We will remain committed to honesty, transparency, and mutual respect. I wish all of you healing, recovery, wellness, and thriving.

Red Hill Response Web Page – U.S. Centers for Disease Control and Prevention (CDC), Agency for Toxic Substances and Disease Registry (ATSDR)

ATSDR has established a web page that briefly explains the Red Hill fuel release and provides a detailed summary of the CDC/ATSDR's Red Hill response activities. The main activities include conducting three Assessment of Chemical Exposure (ACE) investigations, to date, that examine the acute health effects from the release; undertaking a public health assessment to evaluate potential health risks for communities near the facility; and lending technical expertise to the University of Hawai'i (UH), which is developing an independent Red Hill health registry to examine any long-term health effects from the Red Hill fuel release (see below).

Independent Red Hill Health Registry - University of Hawai'i

UH is creating an independent Red Hill health registry to provide support and resources for anyone directly impacted by the Red Hill water crisis. The Red Hill Independent Health Registry ("Red Hill Registry") is a UH Office of Strategic Health Initiatives project funded by a 5-year, \$27.2-million federal cooperative agreement.

This opt-in, third-party registry is being co-developed with the community to provide connections to services and educational programs while tracking participants' long-term health status and gathering information on how fuel exposures may impact health. UH recently completed one of the first tasks as part of the project and delivered a Congressionally-mandated report on the feasibility and necessity of conducting an epidemiological health outcomes study. The report concluded that an epidemiological health outcomes study is both feasible and necessary to advance understanding of the long-term health effects related to the Red Hill fuel release. The feasibility assessment report was delivered to the

National Center for Disaster Medicine and Public Health and was included in the Department of Defense's annual report to Congress on the Red Hill fuel release.

To develop the registry, the UH registry team is <u>currently seeking community input</u> through focus groups and online surveys. The team is also establishing a community oversight working group to ensure community voices are included at each step of the health registry development process. To support these efforts, the team will also seek to hire local community members, including individuals directly affected by the crisis, to support outreach, enrollment, and referral services. A formal online registration portal for the registry is anticipated to launch in the summer of 2025. Enrollment in the UH Independent Red Hill Registry will be strictly voluntary; no one will be automatically enrolled, and you must sign up if you are interested in participating. UH has already established a <u>website for its Red Hill health registry</u> where you can sign up to receive updates and <u>view news</u> on registry development, community engagement efforts, and employment opportunities.

Consensus study report on the potential health implications of the Red Hill fuel leak - The National Academies of Sciences, Engineering, and Medicine

The National Academies of Sciences, Engineering, and Medicine ("National Academies") is assembling a committee of experts to author a report which will review the health risks associated with JP-5 exposure. The report will include recommendations regarding clinical follow-up for those exposed, as well as guidance on clinical actions that can be taken to monitor the health of community members exposed. The report will be released to the public in the spring of 2026.

To understand the needs and priorities of the affected community, the authoring committee will need to hear the varying perspectives and experiences of those exposed to the contaminated drinking water. To accomplish this, the National Academies will establish a volunteer panel of community liaisons to meet with study staff approximately once a month for about a year while the committee is conducting its work.
